Kenneth O. Stinson, Mayor called the meeting to order and Pastor Rick Watson led in prayer, and then followed the Pledge of Allegiance.

Mayor Stinson presented Proclamations to Chief Ricky Fox in honor of National Police Week and to Public Works Director, Terry Vice in honor of National Public Works Week.

It was moved by Council Member Vice that the minutes of prior meetings, copies of which were mailed to each council member prior to the meeting, be approved as written. The motion was seconded by Council Member Hardy and carried.

Mary Vice, City Clerk gave the monthly Administration Department report.

Bills for the month of March, 2019, were approved and payment authorized upon a motion by Council Member Vice, seconded by Council Member Loyd and carried.

Terry Vice, Director of Public Works gave the monthly public works and electrical department reports.

On behalf of Mr. James Kibodeaux, Ms. JoAnne Wagner appeared before the governing authority to request an exception to the Travel Trailer Ordinance to allow Mr. Kibodeaux's son to reside in a travel trailer at 810 Fairchild Street to care for his ill parents.

It was moved by Council Member Hardy to allow the exception to the Travel Trailer Ordinance at 810 Fairchild Street to allow Mr. James Kibodeaux's son (Charles) to live in a travel trailer for a period of 6 months to care for his ill parents. The motion was seconded by Council Member Patin and carried.
