Kenneth Stinson, Mayor called the meeting to order and reported that the purpose of the meeting was as follows:

1. To discuss and/or transact business pertinent to 2019 Budget Amendment

2. To discuss and/or transact business pertinent to Public Hearing and possible adoption of the proposed Budget for the fiscal year ending September 30, 2020.

Phillip Abshire, CPA presented the 2019 Budget Amendment to the governing authority.

It was moved by Council Member Loyd that the 2019 Budget Amendment be adopted as presented. The motion was seconded by Council Member Hardy and carried.

It was moved by Council Member Vice that the regular meeting be recessed for a public hearing to present the 2020 proposed budget. The motion was seconded by Council Member Loyd and carried.

Section 3. Be it further resolved that the adoption of this operating budget of expenditures is by and the same is hereby declared to operate as an appropriation of the amount herein set forth with the terms of budget classification.

Section 4. Be it further resolved that amounts are available for expenditures only to the extent included with the 2019-2020 budget.

Section 5. Be it further resolved that this resolution shall take effect October 1, 2019.
