A RESOLUTION AUTHORIZING EXECUTION AND SIGNING OF A WAIVER OF SERVICE OF SUMMONS BY **JOSEPH DELAFIELD AND** A. **AUTHORIZING** EMPLOYMENT OF SMYSER KAPLAN & VESELKA, L.L.P., TO REPRESENT VINTON PUBLIC POWER **AUTHORITY'S INTERESTS IN** THE JASPER/VPPA SETTLEMENT TRUST, ET AL VS. SAM RAYBURN MUNICIPAL POWER AGENCY, ET AL PROCEEDINGS AND AUTHORIZING EXECUTION AND SIGNING OF ENGAGEMENT LETTER BY PRESIDENT, KENNETH O. STINSON.

WHEREAS, the Board of Directors of Vinton Public Power Authority (the "Authority") previously employed Joseph A. Delafield, A Professional Corporation, to represent its interests relative to its various issues related to the Cambridge Project and Sam Rayburn Municipal Power Agency, et al.;

WHEREAS, the Authority has been notified of a lawsuit filed in the United States District Court for the Southern District of Texas entitled, "C.A. No. 4:20-cv-255; Jasper/VPPA Settlement Trust and Kim Despeaux, Trustee v. WHEREAS, employment of special trial counsel licensed in the State of Texas to represent the Authority is necessary for representation of this proceeding;

WHEREAS, the Authority wishes to employ the firm of Smyser Kaplan & Veselka, L.L.P., to represent the Authority in the Litigation;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors, governing authority of the Authority, as follows:

SECTION 1. The statements of fact expressly contained within the preamble to this Resolution have been specifically reviewed by the Board and are found to be factually true and correct, and are made resolutions of the Authority.

SECTION 2. The Authority hereby authorizes Joseph A. Delafield to sign the Waiver of Service on its behalf, a copy of the Waiver is annexed hereto as Exhibit 1.

SECTION 3. The District hereby employs the firm of Smyser Kaplan & Veselka, L.L.P., for legal representation by counsel in the State of Texas, in accordance with the engagement letter annexed hereto as Exhibit 2.

SECTION 4. The Authority hereby employs Smyser Kaplan & Veselka, L.L.P., to represent it in the proceedings entitled, "C.A. No. 4:20-cv-255; Jasper/VPPA Settlement Trust and Kim Despeaux, Trustee v. Sam Rayburn Municipal Power Agency and Vinton Public Power Authority; In the Unisted States District Court for the Southern District of Texas; Houston Division" and compensation shall be in accordance with the provisions of the engagement letter.

SECTION 5. The Authority hereby authorizes President, Kenneth O. Stinson, to sign the engagement letter of Smyser Kaplan & Veselka, L.L.P.

SECTION 6. This resolution shall take effect immediately upon its adoption.
