Marcus E. Renfrow, Mayor called the meeting to order, and Pastor Rick Watson led in prayer, and then followed the Pledge of Allegiance.

It was moved by Myaor Pro Tem Conner that the minutes of prior meetings, copies of which were mailed to each council member prior to the meeting, be approved as written. The motion was seconded by Council Member Wright and carried.

Justin Sittig, City Clerk gave the monthly Administration Department report.

Bills for the month of July 2021 were approved and payment authorized upon a motion by Council Member Stanley, seconded by Council Member Loyd and carried.

Council Member Loyd made a motion to enter a Public Hearing for public comment on the adoption of the millage. The motion was seconded by Council Member Wright and carried. After no public comment, a motion was made by Council Member Loyd to return to the regular meeting. It was seconded by Council Member Stanley and carried.

Mayor Renfrow advised the Council Members the current millage rate was at 5.38 mills. A motion was made by Council Member Loyd to adopt a resolution to not roll forward on the millage and to remain at 5.38. This motion was seconded by Council Member Wright. The following resolution was presented, and votes were cast.

She advised the council they had begun the building of their new home and progress was being made. Council Member Loyd made a motion to allow a six-month extension. The motion was seconded by Council Member Stanley and carried.
