
BE IT FURTHER RESOLVED that Mayor Renfrow is also authorized and empowered to sign all applications and other pertinent documents regarding said grant.

Anthony Eaves attended the Council meeting, he is a candidate for Court of Appeals.


There being no further business, Council Member Lody made a motion to adjourn the town meeting. The motion was seconded by Council Member Conner and carried.
